TREASURED TREES AFFILIATE PROGRAM

The Treasured Trees Affiliate Program is a fantastic opportunity for individuals, business owners, retailers, website owners, charities and social enterprises to earn an income by promoting our products to their customers and visitors. **We pay a rate of 20% commission on every sale generated by our affiliates.**

AFFILIATE PARTNERS

Affiliate partners can promote Treasured Trees in their locality, via their existing business, direct sales or simply by leaflet distribution. By registering as an affiliate partner you will receive a unique affiliate ID number which when added to the publicity and order forms that you distribute help us to track your sales and calculate your payments. Affiliate partners receive a range of free marketing materials including postcards, flyers and posters to help them get started and promote Treasured Trees to their family, friends and existing customers.

INTERNET BASED AFFILIATES

Affiliates can also register as online affiliates to promote our products online, using websites & email campaigns etc., Online Affiliates can access a wide range of tools include link building, pictures, text and other content to enable affiliates to maximise their income potential. *To become an on-line affiliate please complete the application at www.treasuredtrees.org*

TERMS & CONDITIONS

1. Joining the Program

By filling out the signup form you will automatically become an affiliate and are bound by the terms of this agreement. Your participation in the program is solely for this purpose: to legally advertise our products or website to receive a commission on products purchased by your referral individuals.

2. Payment Schedule

- a. **Eligible payments** - all affiliate monies due for orders generated as a result of affiliate links/Web Site will be held for 30 days after the Shipping Date of an order. Orders are typically shipped 1-7 days after a order is placed. This allows us ample time to compensate for returns, exchanges or canceled orders. Payments will be calculated and sent out to affiliates during the last week of any given month according to the terms and conditions of this document.
- b. **Affiliate Payments** - payment to affiliates will not be rendered for amounts less than £50.00 GBP unless requested by the affiliate. E.g: if you have a total of £50.00 in sales you would have £10.00 in your affiliate account, thus your account will carry over in the next months cycle. When your account total reaches £50.00 or more you will receive your payment by PayPal or Cheque provided all orders associated meet the conditions set forth in (a) above.
- c. Store Credit or Products can be issued upon request in lieu of payment by check to the affiliate. E.g Trees sponsored in your or your company's name.

3. Revocation of affiliate Status

Your affiliate application and status in the program may be suspended or terminated for any of the following reasons:

- Inappropriate advertisements (False claims, misleading hyperlinks or information)
- Spamming (mass email, mass newsgroup posting, etc...)
- Advertising on sites containing/promoting illegal activities
- Violation of intellectual property rights.

4. Affiliate Marketing

You may use graphic and text links both on your Web Site and in emails. Our products may also be advertised "offline" in classified ads, magazines, and newspapers. You may use the graphics and text provided to you by us, or you may create your own as long as they are approved by us first.

5. Online Affiliate Tracking

When a web surfer clicks through your affiliate link, a cookie is set in their browser that contains your affiliate username. Also, their IP address is tracked in the database along with your affiliate name. When this person decides to buy a product, the script will look for this cookie and/or try to match their IP address to identify the affiliate who will be awarded the commission. Visitors sent through your affiliate link may make a purchase later in time and the commission will still be awarded if the cookie is present in their browser and/or are using the same IP address as the one logged in the database.

6. Terms of the agreement

These terms will begin upon your signup with the affiliate program and will end when your affiliate account is terminated. The terms of this agreement may be modified by us at any time. If any modification to the terms is unacceptable to you, your only choice is to terminate your affiliate account. Your continuing participation in the program will constitute your acceptance of any change.

7. Liability

We will not be liable for indirect or accidental damages (loss of revenue, commissions) due to affiliate tracking failures, loss of database files, and any results of "intents of harm" to the program or our website. We do not make any expressed or implied warranties with respect to the affiliate program and/or products sold at this site. We make no claim that the operation of the affiliate program and our website will be error-free and we will not be liable for any interruptions or errors.

The affiliate shall indemnify and hold Treasured Trees harmless from any and all legal actions, damages or liabilities incurred from the day-to-day operations of affiliate. Under no circumstances will Treasured Trees be liable whether in tort, contract or otherwise for indirect, incidental, consequential, special or exemplary damages (including but not limited to damages for any loss of revenue, profits, business interruption, loss of business information or data, loss of goodwill, work stoppage, hardware or software failure, or other pecuniary loss) arising from or relating to any provision of this Agreement or the program. Without limiting the foregoing, Treasured Trees aggregate liability arising with respect to this Agreement will not exceed the total fees paid or payable to affiliate under this agreement.

Treasured Trees will own all right, title and interest in and to all information that is created or collected in the operation of the Treasured Trees Web site and reserves the right to amend or terminate this Agreement at any time, with or without notice to the affiliate.

The laws of the United Kingdom shall govern this Agreement. Should there be any legal dispute between the parties, Treasured Trees request mediation in lieu of formal legal process. Both parties mutually agree that the sole legal venue for all disputes shall be in Manchester, UK.
